
This written summary does not address recommended amendments as may be provided by the standing committee. The Office of Legislative Counsel requests each Council Delegate to review the proposed resolution in detail.

BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Resources and Development Committee is established as a standing committee of the Navajo Nation Council. 2 N.N.C. §500(A).

SECTION TWO. FINDINGS

- A. The Naabik'íyáti' Committee of the Navajo Nation Council established the Naabik'íyáti' Committee Title II Reform Subcommittee through Resolution NABIMY-15-23 on May 20, 2023. *See Exhibit A.*
- B. The Title II Reform Subcommittee is to be composed of two members from each Navajo Nation Standing Committee. *See Exhibit A, Section Two (B).*
