17	The Health, Education and Human Services Committee is a standing committee of the	
18	Navajo Nation Council and serves as the oversight committee for the Division of General	
19	Services with authority to review, recommend or propose the adoption, amendment or	
20	rescission of its Plan of Operation. 2 N.N.C. §§ 400(A), 401(C)(1).

22	SECTION TWO. FINDINGS	
23	A. The Division of General Services (the "Division") is established under the Executive	
24	Branch of the Navajo Nation Government. 2 N.N.C. § 1251.	
25	B. The Division currently operates under the Master Plan as approved by GSCS-69-95	
26	with its individual component departments being amended separately.	
27	C. The Division has submitted a revised Master Plan of Operation for the Division of	
28	General Services and is attached as Exhibit A.	
29	D. An Executive Official Review of the revised Master Plan of Operation has been	
30	completed with the reviewers marking the revisions as legally sufficient. The Executive
