20 SECTION 1. AUTHORITY

- 21 A. The Law and Order Committee is empowered to review and make recommendations
22 to the Navajo Nation Council on proposed amendments and enactments to the Navajo
23 Nation Code. 2 N.N.C. § 601 (B) (14).
24 B. The Resources and Development Committee is a standing committee of the Navajo
25 Nation Council. 2 N.N.C. § 500 (A).
26 C. The Naabik'iyáti' Committee considers proposed resolutions that require final action
27 by the Navajo Nation Council. 2 N.N.C. § 164 (A) (9).
28 D. The Navajo Nation Council approves enactments and amendments of positive law. 2
29 N.N.C. § 164 (A).

1 **SECTION 2. FINDINGS**

2 A. The Resources and Development Committee currently meets on Wednesdays pursuant
3 to 2 N.N.C. § 503.

4 B. The members of the Resources and Development Committee wish to change the
5 Committee's regular meeting day from Wednesdays to Mondays for reasons of
6 efficiency.

8 **SECTION 3. AMENDMENTS TO TITLE 2 OF THE NAVAJO NATION CODE**

9 The Navajo Nation hereby approves amendments to the Navajo Nation Code, Title 2,

26 **SECTION 4. EFFECTIVE DATE**

27 The amendments enacted herein shall be effective pursuant to 2 N.N.C. § 221.

28
29 **SECTION 5. CODIFICATION**

30

1 The provisions of the Act which amend or adopt new sections of the Navajo Nation Code
2 shall be codified by the Office of Legislative Counsel. The Office of Legislative Counsel
3 shall incorporate such amended provisions in the next codification of the Navajo Nation
4 Code.

5
6 **SECTION 6. SAVING CLAUSE**

7 Should any portion of the amendment enacted herein be determined invalid by the Navajo
8 Nation Supreme Court, or the District Court of the Navajo Nation, without appeal to the
9 Navajo Nation Supreme Court, those portions not determined invalid shall remain the law
10 of the Navajo Nation.
