PURPOSE: This legislation, if approved, will enact changes to CAP-35-18, Exhibit D, Project No. 182, for the benefit of the Churchrock Chapter by amending the Project Description to “New Chapter Building and Modular Building” and by amending the Project Type to “Plan, Design, Construct, and Purchase” and by amending the Project Year Funding to “Year 3” for the original amount of \$694,444.44.

FINAL AUTHORITY: Budget and Finance Committee



18 **BE IT ENACTED:**

20 **SECTION ONE. AUTHORITY**

- 21 A. The Resources and Development Committee of the Navajo Nation Council is
22 empowered to exercise oversight authority over Chapter activities. 2 N.N.C. §500(C).
23 B. The Budget and Finance Committee of the Navajo Nation Council is empowered to
24 review and recommend to the Navajo Nation Council the budgeting, appropriation,
25 investment and management of all funds, and to coordinate and review all fiscal,
26 financial and investment activities of the Navajo Nation. 2 N.N.C. §301(B)(2) and
27 §301(B)(5).

28
29 **SECTION TWO. FINDINGS**

1 A. The Navajo Nation Council Resolution No. CAP-35-18, entitled, "Adopting the
2 SÍhasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-
3 14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving
4 12 N.N.C. §§ 810 (F), 820 (I) And (M) And 860 (C) Relating to the Capital
5 Improvement Budget and the Capital Improvement Process" was signed into law by
6 the President of the Navajo Nation on May 7, 2018. CAP-35-18 is included and
7 incorporated herein by reference.

8 1. Section 4 (C) of CAP-35-18 provides: "A chapter project, powerline, or waterline
9 project may be changed, including the year funded, or added to Exhibits A
10 through E with the concurrence of the Delegate representing the chapter's
11 Council District and the approvals of the Resources and Development Committee
12 and Budget and Finance Committee, as long as such project has been certified as
13 construction-ready by CPMD or NTUA and the total SÍhasin Funding for the
14 District does not exceed \$4,166,666.67."

15 2. CAP-35-18, Exhibit D, Project No. 182, originally appropriated \$694,444.44 in
16 SÍhasin Funds for the Churchrock Chapter's Multi-Purpose Building for
17 Design/Construction. **Exhibit 1.**

18 B. The Budget and Finance Committee Resolution No. BFF-08-20, included and
19 incorporated herein by reference, approved a project change to CAP-35-18, Exhibit
20 D, Project No. 182, for the benefit of the Churchrock Chapter. This project change
21 amended the Project Description to "Chapter House Renovation and Addition" and
22 amended the Project Type to "Plan/Design/Construction" and amended the Project
23 Duration to "Year 2" for the original amount of \$694,444.44. **Exhibit 2.**

24 C. The Churchrock Chapter, on behalf of itself and its community, provided Churchrock
25 Chapter Resolution No. CRC-08-2023-006 (certified on August 15, 2023) that
26 requests amendments to CAP-35-18, Exhibit D, Project No. 182 to change the Project
27 Description to "New Chapter Building and Modular Building" and to change the
28 Project Type to "Plan, Design, Construct, and Purchase" and to change the Project
29 Year Funding to "Year 3" for the original amount of \$694,444.44 for the Churchrock
30 Chapter. **Exhibit 3.**

1 D. The Navajo Nation Division of Community Development's Capital Projects
2 Management Department ("CPMD"), on behalf of the Churchrock Chapter, provided
3 a Sihasin Project Amendment Certification form that identifies the Chapter's request
4 to change the Project Description to "New Chapter Building and Modular Building"
5 and to change the Project Type to "Plan, Design, Construct, and Purchase" and to
6 change the Project Year Funding to "Year 3" for the original amount of \$694,444.44.

7 **Exhibit 4.**

8 E. The Sihasin Project Amendment Certification form shows the signature of the Navajo
9 Nation Council Delegate, in accordance with CAP-35-18, Section 4 (C), for the
10 Churchrock Chapter. **Exhibit 4.**

11 F. The Sihasin Project Amendment Certification form shows the signatures of the
12 CPMD, in accordance with CAP-35-18, Section 4 (C), that the project is construction-
13 ready and the total Sihasin Funding for the Council District will not exceed
14 \$4,166,666.67. The original amount of \$694,444.44 in Sihasin Funds for the
15 Churchrock Chapter as appropriated in CAP-35-18, Exhibit D, Project No. 182, will
16 remain the same. **Exhibit 4.**

17
18 **SECTION THREE. APPROVAL**

19 The Navajo Nation Council hereby approves the changes to CAP-35-18, Exhibit D, Project
20 No. 182 for the benefit of the Churchrock Chapter by amending the Project Description to
21 "New Chapter Building and Modular Building" and by amending the Project Type to
22 "Plan, Design, Construct, and Purchase" and by amending the Project Year Funding to
23 "Year 3" for the original amount of \$694,444.44 as shown in **Exhibit 4.**

24
25 **SECTION FOUR. EFFECTIVE DATE**

26 This legislation shall become effective upon its approval pursuant to 12 N.N.C. §2505.

27
28 **SECTION FIVE. SAVING CLAUSE**

29 If any provision of this legislation is determined invalid by the Navajo Nation Supreme Court,
30 or by a Navajo Nation District Court without appeal to the Navajo Nation Supreme Court,

1 those provisions of this legislation not determined invalid shall remain the law of the Navajo
2 Nation.
