PURPOSE: This legislation, if approved, will enact changes to CAP-35-18, Exhibit D, Project No. 182, for the benefit of the Churchrock Chapter by amending the Project Description to "New Chapter Building and Modular Building" and by amending the Project Type to "Plan, Design, Construct, and Purchase" and by amending the Project Year Funding to "Year 3" for the original amount of \$694,444.44.

- A. The Navajo Nation Council Resolution No. CAP-35-18, entitled, "Adopting the Síhasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to CD-68-14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended; Waiving 12 N.N.C. §§ 810 (F), 820 (I) And (M) And 860 (C) Relating to the Capital Improvement Budget and the Capital Improvement Process" was signed into law by the President of the Navajo Nation on May 7, 2018. CAP-35-18 is included and incorporated herein by reference.
 - 1. Section 4 (C) of CAP-35-18 provides: "A chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter's Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as construction-ready by CPMD or NTUA and the total Síhasin Funding for the District does not exceed \$4,166,666.67."
 - CAP-35-18, Exhibit D, Project No. 182, originally appropriated \$694,444.44 in Síhasin Funds for the Churchrock Chapter's Multi-Purpose Building for Design/Construction. Exhibit 1.
- B. The Budget and Finance Committee Resolution No. BFF-08-20, included and incorporated herein by reference, approved a project change to CAP-35-18, Exhibit D, Project No. 182, for the benefit of the Churchrock Chapter. This project change amended the Project Description to "Chapter House Renovation and Addition" and amended the Project Type to "Plan/Design/Construction" and amended the Project Duration to "Year 2" for the original amount of \$694,444.44. Exhibit 2.
- C. The Churchrock Chapter, on behalf of itself and its community, provided Churchrock Chapter Resolution No. CRC-08-2023-006 (certified on August 15, 2023) that requests amendments to CAP-35-18, Exhibit D, Project No. 182 to change the Project Description to "New Chapter Building and Modular Building" and to change the Project Type to "Plan, Design, Construct, and Purchase" and to change the Project Year Funding to "Year 3" for the original amount of \$694,444.44 for the Churchrock Chapter. Exhibit 3.

- D. The Navajo Nation Division of Community Development's Capital Projects Management Department ("CPMD"), on behalf of the Churchrock Chapter, provided a Síhasin Project Amendment Certification form that identifies the Chapter's request to change the Project Description to "New Chapter Building and Modular Building" and to change the Project Type to "Plan, Design, Construct, and Purchase" and to change the Project Year Funding to "Year 3" for the original amount of \$694,444.44. Exhibit 4.
- E. The Síhasin Project Amendment Certification form shows the signature of the Navajo Nation Council Delegate, in accordance with CAP-35-18, Section 4 (C), for the Churchrock Chapter. **Exhibit 4**.
- F. The Síhasin Project Amendment Certification form shows the signatures of the CPMD, in accordance with CAP-35-18, Section 4 (C), that the project is construction-ready and the total Síhasin Funding for the Council District will not exceed \$4,166,666.67. The original amount of \$694,444.44 in Síhasin Funds for the Churchrock Chapter as appropriated in CAP-35-18, Exhibit D, Project No. 182, will remain the same. **Exhibit 4**.

SECTION THREE. APPROVAL

The Navajo Nation Council hereby approves the changes to CAP-35-18, Exhibit D, Project No. 182 for the benefit of the Churchrock Chapter by amending the Project Description to "New Chapter Building and Modular Building" and by amending the Project Type to "Plan, Design, Construct, and Purchase" and by amending the Project Year Funding to "Year 3" for the original amount of \$694,444.44 as shown in **Exhibit 4**.

SECTION FOUR. EFFECTIVE DATE

This legislation shall become effective upon its approval pursuant to 12 N.N.C. §2505.

SECTION FIVE. SAVING CLAUSE

If any provision of this legislation is determined invalid by the Navajo Nation Supreme Court, or by a Navajo Nation District Court without appeal to the Navajo Nation Supreme Court,
