25	SECTION TWO. FINDINGS	
26	A. The Navajo Telecommunications Regulatory Commission (or the "Commission")	
27	is established under 2 N.N.C. §§ 3451-3455.	
28	B. The Commission consists of seven (7) Commissioners appointed by the President	
29	of the Navajo Nation and confirmed by the appropriate committee of the Navajo	
30	Nation Council. 2 N.N.C. § 3454(A).

- C. An appointment to the Commission shall be for a period of four (4) years. 2 N.N.C. § 3454(B).
- D. The President of the Navajo Nation has reappointed Nadine Clah to the Navajo Telecommunications Regulatory Commission. The appointment letter is attached as **Exhibit A**, Ms. Clah's letter of interest is attached as **Exhibit B** and Ms. Clah's resume is attached as **Exhibit C**.
- E. Ms. Clah has previously served on the Commission, with her previous term ending on September 30, 2023.
- F. The Navajo Nation finds it in the best interest of the Navajo Nation to confirm the reappointment of Ms. Nadine Clah to the Navajo Telecommunications Regulatory Commission for a period beginning October 1, 2023 and ending September 30, 2027.

SECTION THREE. CONFIRMATION

The Naabik'íyáti Committee of the Navajo Nation Council, on the recommendation of Resources and Development Committee, hereby confirms the reappointment of Nadine Clah to the Navajo Telecommunications Regulatory Commission for a term beginning October 1, 2023 and ending September 30, 2027.
