PURPOSE: The purpose of this legislation is to confirm the reappointment of Orlando Bowman to the Navajo Telecommunications Regulatory Commission for a term of four (4) years beginning October 1, 2023 and ending September 30, 2027.

16 **BE IT RESOLVED:**

17 **SECTION ONE. AUTHORITY**

- 18 A. The Resources and Development Committee of the Navajo Nation Council has
19 oversight authority with respect to communications and utilities. 2 N.N.C. §
20 500(C).
21 B. The Naabik'iyáti Committee of the Navajo Nation Council is empowered to
22 confirm all appointments to boards and commissions. 2 N.N.C. §§ 700(A),
23 701(A)(1).

25 **SECTION TWO. FINDINGS**

- 26 A. The Navajo Telecommunications Regulatory Commission (or the "Commission")
27 is established under 2 N.N.C. §§ 3451-3455.
28 B. The Commission consists of seven (7) Commissioners appointed by the President
29 of the Navajo Nation and confirmed by the appropriate committee of the Navajo
30 Nation Council. 2 N.N.C. § 3454(A).

- 1 C. An appointment to the Commission shall be for a period of four (4) years. 2
2 N.N.C. § 3454(B).
- 3 D. The President of the Navajo Nation has reappointed Orlando Bowman to the
4 Navajo Telecommunications Regulatory Commission. The appointment letter is
5 attached as **Exhibit A**, Mr. Bowman’s letter of interest is attached as **Exhibit B**
6 and Mr. Bowman’s resume is attached as **Exhibit C**.
- 7 E. Mr. Bowman has previously served on the Commission, with his previous term
8 ending on September 30, 2023.
- 9 F. The Navajo Nation finds it in the best interest of the Navajo Nation to confirm the
10 reappointment of Mr. Orlando Bowman to the Navajo Telecommunications
11 Regulatory Commission for a period beginning October 1, 2023 and ending
12 September 30, 2027.

14 **SECTION THREE. CONFIRMATION**

15 The Naabik’íyáti Committee of the Navajo Nation Council, on the recommendation
16 of Resources and Development Committee, hereby confirms the reappointment of
17 Orlando Bowman to the Navajo Telecommunications Regulatory Commission for a
18 term beginning October 1, 2023 and ending September 30, 2027.
