19 SECTION ONE. AUTHORITY

- 20 A. The Law and Order Committee (“LOC”) is a standing committee of the Navajo Nation
21 Council with oversight authority over the Navajo Nation Division of Public Safety
22 (“DPS”). 2 N.N.C. §600(A); 2 N.N.C. §601(C)(1).
23 B. The Budget and Finance Committee (“BFC”) is a standing committee of the Navajo
24 Nation Council authorized to make recommendations to the Council on the budgeting
25 and management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The BFC is
26 specifically authorized to make recommendations to the Council regarding the Navajo
27 Nation’s annual Comprehensive Budget for each Fiscal Year. 12 N.N.C. § 840(A).

29 SECTION TWO. FINDINGS

- 30 A. The Law and Order Committee and the Budget and Finance Committee held budget

1 meetings and heard reports from Program staff and the Office of Management and
2 Budget regarding the proposed FY2025 Budget for the Division of Public Safety. 12
3 N.N.C. § 840(A).

4 B. The Navajo Nation Appropriations Act states that Oversight Committee budget
5 recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).

6 C. The Budget and Finance Committee finds that approval of the proposed FY2025 Budget
7 for the Division of Public Safety and inclusion of such Budget in the Navajo Nation's
8 FY2025 Comprehensive Budget is in the best interest of the Navajo Nation.

10 **SECTION THREE. LAW AND ORDER COMMITTEE RECOMMENDING TO THE**
11 **BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2025 BUDGET FOR**
12 **THE DIVISION OF PUBLIC SAFETY AND RELATED MATTERS**

13 A. The Law and Order Committee hereby recommends the FY2025 Budget for the Division
14 of Public Safety, as detailed in the "Fund Type Budget Summary" attached hereto as
15 **Exhibit A.**

16 B. The Law and Order Committee hereby approves certain revisions, if any, to the proposed
17 FY2025 Budget amount for the Division of Public Safety, as shown in Columns D and
18 E in the "General Fund Comparative Summary" attached hereto as **Exhibit B.**

19 C. The Law and Order Committee recommends the changes, if any, to the General Fund
20 Budget described in **Exhibit C.**

21 D. The Law and Order Committee recommends certain Conditions of Appropriation and
22 Legislative Concerns, if any, as listed in **Exhibit D.**

23 E. The Law and Order Committee recommends that certain Unmet Needs, if any, for the
24 Division of Public Safety be included in the FY2025 Comprehensive Budget, as
25 explained in **Exhibit E.**

26 F. The Law and Order Committee has been presented with the External Funds Anticipated
27 in FY2025, if any, as listed in **Exhibit F.**

28 G. The Law and Order Committee recommends that the Budget and Finance Committee
29 approve the Labor Commission FY2025 Budget and all Committee recommendations as
30 set forth in **Exhibits A-E** and further explained in the LOC Committee Report attached

1 Committee Report attached as **Exhibit G**.

2 H. The Law and Order Committee hereby authorizes the Chair and the Vice-Chair to
3 negotiate with the Budget and Finance Committee on these recommendations.

16 Exhibits and/or updates to Budget Binder documents, as approved by the LOC.

17 B The Office of Legislative Services shall attach the BFC Committee Report as **Exhibit H**,
18 reflecting all amendment(s), if any, made to this Action, including amendments to
19 Exhibits and/or updates to Budget Binder documents, as approved by the BFC.
