BE IT ENACTED:

SECTION ONE. AUTHORITY

1. The Resources and Development Committee exercises authority over chapters of the Navajo Nation. 2 N.N.C. § 501(C)(1).
2. The Budget and Finance Committee of the Navajo Nation Council exercises authority over budgeting, appropriation, investment and management of all funds. 2 N.N.C. § 301 (B)(2).
3. Council Resolution CAP-35-18 provides, “[a] chapter project, powerline, or waterline project may be changed, including the year funded, or added to Exhibits A through E with the concurrence of the Delegate representing the chapter’s Council District and the approvals of the Resources and Development Committee and Budget and Finance Committee, as long as such project has been certified as construction-ready by CPMD or NTUA and the total Síhasin Funding for the District does not exceed \$4,166,666.67.”

1 **SECTION TWO. FINDINGS**

- 2 A. The Navajo Nation Council approved Council Resolution CAP-35-18, “Adopting
3 the Sihasin Fund Powerline and Chapter Projects Expenditure Plan Pursuant to
4 CD-68-14, as Amended by CJA-03-18, and 12 N.N.C. §§ 2501-2508, as Amended;
5 Waiving 12 N.N.C. §§ 810 (F), 820 (I) and (M) and 860 (C) Relating to the Capital
6 Budget and Capital Improvement Process” on April 17, 2018.
- 7 B. The Nenahnezad Chapter Project is listed in Resolution CAP-35-18 at Exhibit D,
8 Project Number 7. Resolution CAP-35-18, Exhibit D is attached as **Exhibit 1**.
- 9 C. Nenahnezad Chapter submitted a Sihasin Project Change Request Form (the
10 “Form”), which is attached as **Exhibit 2**, and includes a chapter resolution. The
11 chapter resolution, while not a legal requirement for project changes pursuant to
12 CAP-35-18, is included for information purposes.
- 13 D. The Form submitted by Nenahnezad Chapter requests the following changes be
14 made to Project 7 as described in Resolution CAP-35-18, as indicated below:

17 Multi-purpose Building Renovation from Year 2 for \$694,444.44

- 20 1. Planning, Designing, and Construction for the Nenahnezad Chapter
21 House Roof Repair, in Year 3, for \$ 200,000;
- 22 2. Planning, Designing, and Construction of the Nenahnezad Chapter House
23 Warehouse, in Year 3, for \$ 280,444.44;
- 24 3. Nenahnezad Chapter Farm Equipment Purchase, in Year 3, for \$100,000
- 25 4. Nenahnezad Chapter Skidsteer Purchase, Year 3, for \$114,000
