. 23	B. The Resources and Development Committee shall review and make recommendations to	
24	the Budget and Finance Committee concerning the budget in accordance with the annual	
25	budget instructions. 12 N.N.C. § 840 (A).	
26	C. The Budget and Finance Committee is a standing committee of the Navajo Nation	
27	Council authorized to make recommendations to the Council on the budgeting and	
28	management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The Budget and	
29	Finance Committee is specifically authorized to make recommendations to the Council	
30	regarding the Navajo Nation's annual Comprehensive Budget for each Fiscal Year. 12

SECTION TWO. FINDINGS

- A. The Resources and Development Committee and the Budget and Finance Committee held budget meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed FY2026 Budget for the Navajo Nation Environmental Protection Agency. 12 N.N.C. § 840(A).
- B. The Resources and Development Committee, Committee Report shall be attached as Exhibit G and the Budget and Finance Committee, Committee Report shall be attached as Exhibit H.
- C. Pursuant to the Navajo Nation Appropriations Act, Oversight Committee budget recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).

SECTION THREE. RESOURCES AND DEVELOPMENT COMMITTEE RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2026 BUDGET FOR THE NAVAJO NATION ENVIRONMENTAL PROTECTION AGENCY AND RELATED MATTERS

 Appropriation and Legislative Concerns, if any, as listed in **Exhibit D**, and in the Resources and Development Committee's Report to be attached as **Exhibit G**.

- E. The Resources and Development Committee recommends that certain Unmet Needs, if any, for the Division of Community Development be included in the FY2026 Comprehensive Budget, as explained in **Exhibit E**, and in the Resources and Development Committee's Report to be attached as **Exhibit G**.
- F. The Resources and Development Committee has been presented with the External Funds Anticipated in FY2026, if any, as listed in **Exhibit F**.
- G. The Resources and Development Committee recommends that the Budget and Finance Committee approve the Navajo Nation Environmental Protection Agency's FY2026 Budget and all Committee recommendations as set forth in Exhibits A-E and Exhibit
 G, the Resources and Development Committee, Committee Report.
- H. The Resources and Development Committee hereby authorizes the Chairwoman and the Vice-Chairman to negotiate with the Budget and Finance Committee on these recommendations.
