

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee ("HEHSC") is a standing committee of the Navajo Nation Council with oversight authority over the Navajo Nation Division of Human Resources ("DHR"). 2 N.N.C. §400(A); 2 N.N.C. §401(C)(1).
- B. The Budget and Finance Committee is a standing committee of the Navajo Nation Council authorized to make recommendations to the Council on the budgeting and management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The Budget and Finance Committee is specifically authorized to make recommendations to the Council regarding the Navajo Nation's annual Comprehensive Budget for each Fiscal Year. 12 N.N.C. § 840(A).

1 **SECTION TWO. FINDINGS**

- 2 A. The Health, Education and Human Services Committee and the Budget and Finance
3 Committee held budget meetings and heard reports from Program staff and the Office of
4 Management and Budget regarding the proposed FY2026 Budget for the Navajo Nation
5 Division of Human Resources. 12 N.N.C. § 840(A).
- 6 B. The Health, Education and Human Services Committee, Committee Report shall be
7 attached as **Exhibit G** and the Budget and Finance Committee, Committee Report shall
8 be attached as **Exhibit H**.
- 9 C. Per the Navajo Nation Appropriations Act, Oversight Committee budget
10 recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).
- 11 D. The Budget and Finance Committee finds that approval of the proposed FY2026 Budget
12 for the Navajo Nation Division of Human Resources and inclusion of such Budget in the
13 Navajo Nation's FY2026 Comprehensive Budget is in the best interest of the Navajo
14 Nation.

- 20 A. The Health, Education and Human Services Committee hereby recommends the FY2026
21 Budget for the Navajo Nation Division of Human Resources, as detailed in the "Fund
22 Type Budget Summary" attached hereto as **Exhibit A**, and in the Health, Education and
23 Human Services Committee's Report, to be attached as **Exhibit G**.
- 24 B. The Health, Education and Human Services Committee hereby approves certain
25 revisions, if any, to the proposed FY2026 Budget amount for the Navajo Nation Division
26 of Human Resources, as shown in Columns D and E in the "General Fund Comparative
27 Summary" attached hereto as **Exhibit B**, and in the Health, Education and Human
28 Services Committee's Report to be attached as **Exhibit G**.
- 29 C. The Health, Education and Human Services Committee recommends the changes, if any,
30 to the General Fund Budget described in **Exhibit C**, and in the Health, Education and

Human Services Committee's Report to be attached as **Exhibit G**.

D. The Health, Education and Human Services Committee recommends certain Conditions of Appropriation and Legislative Concerns, if any, as listed in **Exhibit D**, and in the Health, Education and Human Services Committee's Report to be attached as **Exhibit G**.

E. The Health, Education and Human Services Committee recommends that certain Unmet Needs, if any, for the Navajo Nation Division of Human Resources be included in the FY2026 Comprehensive Budget, as explained in **Exhibit E**, and in the Health, Education and Human Services Committee's Report to be attached as **Exhibit G**.

F. The Health, Education and Human Services Committee has been presented with the External Funds Anticipated in FY2026, if any, as listed in **Exhibit F**.

G. The Health, Education and Human Services Committee recommends that the Budget and Finance Committee approve the Navajo Nation Division of Human Resources FY2026 Budget and all Committee recommendations as set forth in **Exhibits A-E and Exhibit G**, the Health, Education and Human Services Committee, Committee Report.

H. The Health, Education and Human Services Committee hereby authorizes the Chair and the Vice-Chair to negotiate with the Budget and Finance Committee on these recommendations.

SECTION FOUR. BUDGET AND FINANCE COMMITTEE APPROVING THE FISCAL YEAR 2026 BUDGET FOR THE NAVAJO NATION DIVISION OF HUMAN RESOURCES AND RELATED MATTERS

The Budget and Finance Committee approves the Navajo Nation Division of Human Resources FY2026 Budget as set forth in **Exhibits A-E** and in the Budget and Finance Committee's, Committee Report, **Exhibit H**, to serve as the BFC's recommendations to the Navajo Nation Council for including in the FY2026 Comprehensive Budget.

SECTION FIVE. DIRECTIVES

A. The Office of Legislative Services shall attach **Exhibit G**, the Health, Education and Human Services Committee's Committee Report, that reflects all amendment(s) made to

1 this Action (Exhibits and Budget Binder documents) that are approved by the Health,
2 Education and Human Services Committee and that serve as the Health, Education and
3 Human Services Committee's recommendations to the Budget and Finance Committee.

- 4 B The Office of Legislative Services shall attach **Exhibit H**, the Budget and Finance
5 Committee's Committee Report, that reflects all amendment(s) made to this Action
6 (Exhibits and Budget Binder documents) as approved by the BFC.

8 **SECTION SIX. EFFECTIVE DATE**
