BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Budget and Finance Committee is established as a standing committee of the Navajo Nation Council. 2 N.N.C. §300(A).

SECTION TWO. FINDINGS

A. Standing committees are required to select a member to serve as a Shareholder Representative or Member Representative for certain Navajo Nation enterprises.

B. The Operating Agreement of the Navajo Transitional Energy Company, LLC, at Article III (C) states that the membership interest in the Company "shall be exercised by five (5) "member representatives," composed of one (1) member from each of the five (5) standing committees of the Navajo Nation Council (or their successor committees)"

1 C. The member representative position to the Navajo Transitional Energy Company from
2 the Budget and Finance Committee is currently vacant and the Committee should appoint
3 a representative to fill the position.
