**RELATING TO THE BUDGET AND FINANCE COMMITTEE; APPROVING AND
RECOMMENDING THE FISCAL YEAR 2026 BUDGET FOR THE OFFICE OF
MANAGEMENT AND BUDGET**

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Office of Management and Budget. 2 N.N.C. §300(A) and (B)(2).
- B. Each Oversight Committee, including the Budget and Finance Committee, shall review and make recommendations regarding the programs under its oversight responsibility, regarding the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

SECTION TWO. FINDINGS

- A. The Office of Management and Budget prepared the following document in support of its Fiscal Year ("FY") 2026 Budget:
1. Fund Type Budget Summary, as provided in **Exhibit A**;
 2. General Fund Comparative Summary, as provided in **Exhibit B**;

3. Changes to the General Fund Budget, as provided in **Exhibit C**;
4. Recommended Conditions of Appropriation and Legislative Concerns, as provided in **Exhibit D**;
5. Recommended Unmet Needs, as provided in **Exhibit E**; and
6. Anticipated External Funds, as provided in **Exhibit F**. This exhibit is provided for information purposes only and as such is not subject to amendment since these are not Navajo Nation General Funds.

SECTION THREE. APPROVING AND RECOMMENDING THE FISCAL YEAR 2026 BUDGET FOR THE OFFICE OF MANAGEMENT AND BUDGET
