21	B. Each Oversight Committee, including the Naabik'íyáti' Committee, shall review and	
22	make recommendations regarding the programs under its oversight responsibility,	
23	regarding the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12
