23	B. A proposed resolution requiring final action by the Navajo Nation Council shall be	
24	assigned to the Naabik'íyátí Committee. 2 N.N.C. §164(A)(9).	
25	C. The Resources and Development Committee is a standing committee of the Navajo	
26	Nation Council with oversight authority over the Division of Community	
27	Development. 2 N.N.C. § 501 (C)(1).

- A. The Navajo Nation Code provides, that the Navajo Division of Community Development "shall be administered by a Division Director, who shall be appointed by the President of the Navajo Nation, confirmed by the Navajo Nation Council, and who shall serve at the pleasure of the President of the Navajo Nation." 2 N.N.C. § 1453 (A).
- B. The Navajo Nation President appoints Candice Yazzie as the Division Director for the Division of Community Development. Candice Yazzie's appointment letter and resume are attached as **Exhibit A**.

SECTION THREE. CONFIRMATION

The Navajo Nation Council confirms the Navajo Nation President's appointment of Candice Yazzie as the Division Director for the Division of Community Development.
