**PURPOSE:** This purpose of this proposed resolution is to approve a lease between the Navajo Nation and Painted Desert Power, LLC for approximately 4,500 acres for a 750 megawatt solar energy and battery storage project located in the Coalmine Canyon area (Coconino County, Arizona).

. 21	Pursuant to 2 N.N.C. Section §501 (B)(2), the Resources and Development Committee	
22	of the Navajo Nation Council has the authority to grant final approval for all land	
23	withdrawals, non-mineral leases, permits, licenses, rights-of-way, surface easements	
. 24	and bonding requirements on Navajo Nation lands and unrestricted (fee) land. This	
25	authority shall include subleases, modifications, assignments, leasehold encumbrances,

. 29	A. Painted Desert Power, LLC seeks approval of a lease to construct, install, and develop	
30	a 750-megawatt (750MW) photovoltaic solar generating and battery storage project in	
	the Coalmine Canyon Chapter of the Navajo Nation Reservation, approximately four

- (4) miles east of the town of Cameron, Arizona. The lease is being entered into in accordance with the Navajo Nation's General Leasing Regulations found at 16 N.N.C. § 2301 et seq. The lease is attached as **Exhibit A**.
- B. The lease covers 4,500 acres, more or less, as described in the survey map and legal description of the leased premises attached as **Exhibit B**.
- C. The lease states that Painted Desert Power, LLC is requesting a waiver of a performance bond in accordance with 16 N.N.C. § 2335(B).
- D. There are eighteen (18) grazing permittees within the proposed project area. The corresponding Field Checklist and "Consent to Use Navajo Nation Lands" forms from all eighteen permittees are herein attached as **Exhibit C.**
- E. The General Land Development Department's Environmental Compliance Determination is attached as **Exhibit D**. The Cultural Resources Compliance Form is attached as **Exhibit E**. The Biological Resources Compliance Form is attached **Exhibit F**.
- F. A supporting resolution from the Coalmine Canyon Chapter is attached as Exhibit G.
- G. The proposed lease and supporting documentation have been reviewed through Executive Official Review Document Number 022001, which is attached as **Exhibit** H.
- H. The Navajo Nation understands that Painted Desert Power, LLC will also require a right-of-way from the Navajo Nation for a transmission line of approximately four (4) miles that will be associated with this solar and battery storage project. The right-of-way will be a separate discussion between the Navajo Nation and Painted Desert Power, LLC and will be subject to an approval process separate and apart from this resolution.

## SECTION THREE. APPROVAL

A. The Resources and Development Committee of the Navajo Nation Council hereby approves the lease, attached as **Exhibit A**. The location is more particularly described on the survey map attached hereto as **Exhibit B**.
