

COUNCIL; CONFIRMING THE APPOINTMENT OF REYCITA TODDY AS THE
EXECUTIVE DIRECTOR OF THE DIVISION OF HUMAN RESOURCES

SECTION ONE. AUTHORITY

- A. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 400(A). The Health, Education and Human Services Committee exercises oversight authority over the Division of Human Resources. 2 N.N.C. § 401(C)(1).
- B. The Naa'bik'iyáti' Committee is a standing committee of the Navajo Nation Council. The Committee reviews all legislation requiring final action by the Navajo Nation Council. 2 N.N.C. §§ 164 (A)(9), 700 (A).
- C. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102 (A).

SECTION TWO. FINDINGS

- A. The establishment of the Division of Human Resources and the duties of the Executive Director are outlined at 2 N.N.C. § 1701 *et seq.*

1 B. The Executive Director of the Division of Human Resources shall be appointed by and
2 serve at the pleasure of the President of the Navajo Nation and confirmed by the Navajo
3 Nation Council. 2 N.N.C. §1703(A)(2).

4 C. The Navajo Nation President appointed Reycita Toddy as the Executive Director of the
5 Navajo Division of Human Resources. Reycita Toddy's appointment letter and résumé
6 are attached as **Exhibit A**.

8 **SECTION THREE. CONFIRMING THE APPOINTMENT OF THE EXECUTIVE**
9 **DIRECTOR OF THE DIVISION OF HUMAN RESOURCES**
