SECTION THREE. CONFIRMING THE APPOINTMENT OF THE EXECUTIVE DIRECTOR OF THE DIVISION OF HUMAN RESOURCES

The Navajo Nation Council hereby confirms the appointment of Reycita Toddy as the Executive Director of the Division of Human Resources.
