SECTION TWO. FINDINGS

- A. The establishment of the Navajo Nation Division of Transportation ("NDOT") is outlined at 2 N.N.C. § 1370.
- B. According to the revised NDOT Plan of Operation, approved in Resolution No. CAP-13-13, the Executive Director of the Navajo Nation Division of Transportation is appointed by the Navajo Nation President and confirmed by the Navajo Nation Council. See NDOT Plan of Operation (revised), Section III(A)(2).
- C. The Navajo Nation President Dr. Buu Nygren appointed Tommy Platero as the Executive Director of the Navajo Nation Division of Transportation. Tommy Platero's appointment letter and résumé are attached as **Exhibit A**.

SECTION THREE. CONFIRMING THE APPOINTMENT OF THE EXECUTIVE DIRECTOR OF THE NAVAJO NATION DIVISION OF TRANSPORTATION

The Navajo Nation Council hereby confirms Navajo Nation President Dr. Buu Nygren's appointment of Tommy Platero as the Executive Director of the Navajo Nation Division of Transportation.
