19	The Resources and Development Committee of the Navajo Nation Council has the authority to	
20 21	grant final approval for all land withdrawals, non-mineral leases, permits, licenses, rights-of-way, surface easements and bonding requirements on Navajo Nation lands and unrestricted (fee) land.	
22	This authority shall include subleases, modifications, assignments, leasehold encumbrances,	
23	transfers, renewals, and terminations. 2 N.N.C. § 501(B)(2).

25	SECTION TWO. FINDINGS	
26	A. The Chinle Unified School District #24 (or the "School District") seeks approval of an	
27	updated lease for lands located in the Chinle Chapter of the Navajo Nation Reservation for	
28	the purpose of constructing, maintaining and operating facilities consistent with the	
29	principal use of the leased premises for a school, which includes housing for teachers and	
30	other individuals necessary for the operation of the School District's educational mission.
