19	A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).	
20	B. A proposed resolution requiring final action by the Navajo Nation Council shall be	
21	assigned to the Naabik'íyáti' Committee. 2 N.N.C. § 164(A)(9).

23	SECTION TWO. FINDINGS	
24	A. The Navajo Nation Code provides, "[t]he [Executive] Director [of the Navajo Nation	
25	Washington Office] shall be appointed by the President of the Navajo Nation, subject to	
26	confirmation by the Navajo Nation Council, to serve at a negotiated salary and at the	
27	pleasure of the President of the Navajo Nation." 2

- B. The Navajo Nation President has appointed Mr. Vince Redhouse as the Executive Director of the Navajo Nation Washington Office. President Dr. Buu Nygren's appointment letter for Mr. Redhouse is attached as **Exhibit A**.
- C. Mr. Vince Redhouse's qualifications and experience to serve as the Executive Director of the Navajo Nation Washington Office are described in a letter attached as **Exhibit B**.
- D. Teec Nos Pos Chapter has submitted Resolution TNPCH-06-27-2025-FY25-R-78, in support of the appointment of Mr. Vince Redhouse as Executive Director of the Navajo Nation Washington Office and recommend the confirmation of Mr. Redhouse by the Navajo Nation Council.
