21 as a standing committee of the Navajo Nation Council.
22 B. The Naabik'iyáti' Committee of the Navajo Nation Council established the Title II
23 Reform Subcommittee through Resolution NABIMY-15-23 on May 20, 2023, attached
24 as **Exhibit A**.

26 SECTION TWO. FINDINGS

- 27 A. Pursuant to NABIMY-15-23 §2(B), the Title II Reform Subcommittee is to be composed
28 of two members from each Navajo Nation Standing Committee.
29 A. Resources and Development Chair Brenda Jesus requests to be replaced on the Title II
30 Reform Subcommittee. As per Chair Jesus' request to be replaced, another member of

1 the Resources and Development Committee needs to be appointed to the Title II
2 Reform Subcommittee.
