PURPOSE: This purpose of this proposed resolution is to approve a Temporary Construction Easement for the Navajo Department of Transportation related to a roadway improvement project on N12 in the Tsaile/Wheatfields vicinity. The Temporary Construction Easement is for a three-year term and covers nineteen different locations consisting of 2.3193 acres.

26	SECTION TWO. FINDINGS A. The Neuric Department of Transportation is requesting a Temperature Construction

- hardship/difficult traveling conditions during the winter and rainy seasons, especially for community travelers, school buses, public safety agencies, health care facilities, government service providers, and emergency responders.
- B. The Terms and Conditions for the Temporary Construction Easement are attached as **Exhibit A**.
- C. The Temporary Construction Easement covers nineteen (19) different locations consisting of 2.3193 acres, with the corresponding legal land surveys herein attached as **Exhibit B**.
- D. The Temporary Construction Easement term is three (3) years, with the value assessed by the Navajo Nation Minerals Department totaling \$7,917.69. The assessment is attached as **Exhibit C**.
- E. The Navajo Department of Transportation is seeking a waiver of the compensation for the Temporary Construction Easement given the benefits of this road improvement project to the Tsaile/Wheatfields community and the general public.
- F. The Cultural Resources Compliance Form, Biological Resources Compliance Form, Environmental Compliance Determination and a Finding of No Significant Impact executed by the Bureau of Indian Affairs Regional Director Gregory Mehojah dated September 9, 2023 are attached as **Exhibit D**.
- G. The grazing permittee consents are herein attached as Exhibit E.
- H. Tsaile/Wheatfields Chapter Resolution TWFY-24-104 supporting the Temporary Construction Easement is attached as **Exhibit F**.
- I. Executive Official Review document number 024540 is attached as Exhibit G.

SECTION THREE. APPROVAL

A. The Resources and Development Committee of the Navajo Nation Council hereby approves the request for a Temporary Construction Easement to the Navajo Department of Transportation subject but not limited to the Terms and Conditions attached hereto and incorporated herein as found at **Exhibit A**. The legal land surveys are attached as **Exhibit B**. The request for a waiver of the consideration for this Temporary Construction Easement is also approved.

B. The Resources and Development Committee of the Navajo Nation Council hereby authorizes the President of the Navajo Nation to execute any and all documents necessary to affect the intent and purpose of this resolution.
