18	SECTION ONE. AUTHORITY	
19	A. The Navajo Nation Council established the Resources and Development Committee	
20	as a Standing Committee of the Navajo Nation Council. 2 N.N.C. § 500 (A).	
21	B. Pursuant to 2 N.N.C. § 501 (B)(9), the Resources and Development Committee has	
22	authority to grant final confirmation to enterprise boards.	
23	C. Pursuant to 5 N.N.C. § 1503 (C), the Navajo Arts and Crafts Enterprise Board of	
24	Directors shall be appointed by the President of the Navajo Nation subject to	
25	confirmation by the Economic Development Committee of the Navajo Nation	
26	Council, whose authority to confirm appointments to the enterprise boards has since	
27	been delegated to the Resources and Development Committee. 2 N.N.C. § 501	
28	(B)(9); CO-45-12.	
29	D. The Navajo Arts and Crafts Enterprise ("NACE") Plan of Operation provides that a	
30	vacancy not filled by a qualified candidate appointed by the President within 60 days

of the occurrence of that vacancy shall be filled by an appointment and confirmation made by the Resources and Development Committee. NACE Plan of Operation, Article 4 (E)(2).

SECTION TWO. FINDINGS

- A. The NACE Board of Directors is to be composed of five members, with one member being represented by a Navajo Nation Council Delegate. 2 N.N.C. § 1503 (A).
- B. The term of the Navajo Nation Delegate as board member shall be identical to their term as a member of the Navajo Nation Council. NACE Plan of Operation, Article 4

 (A).
- C. The President of the Navajo Nation has not appointed a Navajo Nation Council Delegate to the NACE Board of Directors for confirmation by the Resources and Development Committee.
- D. In accordance with the NACE Plan of Operation, Article 4 (E)(2), the Resources and Development Committee will fill the vacant Council Delegate NACE Board position by appointing and confirming Delegate Shawna Ann Claw to the NACE Board of Directors.

SECTION THREE. CONFIRMING APPOINTMENT

The Resources and Development Committee appoints and confirms Delegate Shawna Ann Claw as the Navajo Nation Council Delegate member of the Navajo Arts and Craft Enterprise Board of Directors for a term to coincide with her term as a Council Delegate.
