**CHAPTER PROJECTS APPROVED IN RESOLUTION CAP-35-18 FOR**  
**ADDITIONAL JEDDITO CHAPTER PROJECTS**

BE IT ENACTED:

**SECTION ONE. AUTHORITY**

- A. The Resources & Development Committee is a standing committee of the Navajo Nation Council with oversight authority over chapter activities. 2 N.N.C. §500(C).
- B. The Resources & Development Committee is authorized to give approval for the cost savings on certain projects to be used on different projects, as long as the cost savings are applied to projects that comply with the Chapter and District restrictions set forth in §4(B)(3).
- C. Project costs saved or reduced through leveraging or other means shall be available for expenditure on any other project within the respective chapter deemed construction-ready by CPMD; if there are no construction-ready projects within the respective chapter, then, with approval of the Resource and Development Committee, the saved or reduced costs shall be available for expenditure on any other project within the respective District. Resolution CAP-35-18, §4(B)(3).

2 **SECTION TWO. FINDINGS**

3     A. Resolution CAP-35-18 approved projects for Jeddito Chapter in Exhibit D, Projects 130  
4         and 131. These projects resulted in cost savings of \$28,270 from the initial funding  
5         allocation total of \$726,268.67. Jeddito Chapter requests the cost savings be put toward  
6         renovations for its chapter house.

7     B. Resolution CAP-35-18 allows the Resources and Development Committee to approve  
8         new projects where cost savings are identified. CAP-35-18, Section Four (4)(B)(3).

9     C. Jeddito Chapter identified \$28,270 in cost savings after the completion of the two  
10        bathroom addition projects under its approved Sihasin Fund Expenditure Plan. An  
11        explanation of the project cost savings and its \$28,270 calculation is provided and  
12        attached as **Exhibit A**.

14 **SECTION THREE. APPROVAL OF COST SAVINGS**

15 The Resources and Development Committee of the Navajo Nation Council approves the \$28,270  
16 in cost savings by Jeddito Chapter as detailed in **Exhibit A**.
