18	SECTION ONE. AUTHORITY	
19	A. The Naabik'íyáti Committee is a standing committee of the Navajo Nation Council has	
20	the authority to grant final confirmation of appointments to boards, commissions, and	
21	colleges unless otherwise provided in law. 2 N.N.C. § 701 (A) (1).	
22	B. An appointment to the Black Mesa Review Board as made by the respective Chapter	
23	requires confirmation by the [Naabik'íyáti] Committee. 2 N.N.C. § 903(B).

25	SECTION TWO. FINDINGS	
26	A. The purpose of the Black Mesa Review Board (the "Board") shall be to advocate for fair	
27	and just compensation for Navajo families within the five Navajo Nation Chapters whose	

A. The purpose of the Black Mesa Review Board (the "Board") shall be to advocate for fair and just compensation for Navajo families within the five Navajo Nation Chapters whose socio-economic and environmental interests are adversely affected or impacted by coal mining and related operations of Peabody Western Coal Company ("PWCC"). The Board may also make appropriate recommendations to the President of the Navajo Nation, the

- Navajo Nation Council, the Resources and Development Committee of the Navajo Nation Council, or to PWCC, concerning the health, social welfare, education, and environment of the Navajo People affected by any of PWCC's mining and post-mining or related operations. 2 N.N.C. § 902.
- B. The Black Mesa Review Board shall be comprised of seven (7) members, one of whom shall be appointed by the Speaker of the Navajo Nation Council. Each Board appointee shall serve a term of four (4) years. 2 N.N.C. § 903.
- C. The Speaker of the Navajo Nation Council, Speaker Crystalyne Curley, has appointed Mr. Carl Etsitty to the Black Mesa Review Board, Speaker Curley's appointment letter of Mr. Carl Etsitty is attached as **Exhibit A**.
- D. Mr. Etsitty demonstrates the appropriate background and experience to serve on the Black Mesa Review Broad by submitting a letter of interest and resume, which is attached as **Exhibit B**.
- E. Within thirty (30) days of appointment, each Board appointee shall be presented to the Naabik'íyáti Committee of the Navajo Nation Council for confirmation. 2 N.N.C. § 903 (B).
- F. If confirmed by the Naabik'íyáti Committee, Mr. Etsitty's term shall not commence until he is administered an oath of office by a judge or justice of the Navajo Nation courts. 2 N.N.C. § 903 (B).

## SECTION THREE. CONFIRMATION

The Naabik'íyáti Committee of the Navajo Nation Council hereby confirms the appointment of Mr. Carl Etsitty as the Speaker of the Navajo Nation Council's representative to the Black Mesa Review Board for a term of four (4) years.
