19	A. The Budget and Finance Committee shall make recommendations concerning the budget and	
20	submit it to the Navajo Nation Council for deliberation and approval. 12 N.N.C. § 840(A).

25	SECTION TWO. FINDINGS	
26	A. The Navajo Nation Council approved CS-44-25, the Navajo Nation Fiscal Year 2026	
27	Comprehensive Budget, on September 4, 2025, the resolution was certified and submitted

SECTION THREE. AMENDING CS-44-25, THE NAVAJO NATION FISCAL YEAR 2026 BUDGET

- A. The Navajo Nation hereby approves the appropriations for Navajo Nation Fiscal Year 2026 as listed here for the Executive Branch for the following items, totaling 4,709,472, from the General Funds. Upon approval, each Program will submit complete budget packets, including authorized signatures, to the Office of the Controller and the Office of Management and Budget based on the appropriations, as indicated in **Exhibit A** and as follows:
 - 1. Office of the President and Vice President, BU# 103001, in the amount of \$1,595,795.
 - 2. Office of the Public Defender, BU# 104003, in the amount of \$168,517.
 - 3. DCD Administrative Service Centers, BU# 108125, in the amount of \$67,050.
 - 4. Division of Human Resources Administration, BU# 114001, in the amount of \$99,539.
 - 5. Office of Navajo Labor Relations, BU# 114004, in the amount of \$51,925.
 - 6. Department of Personnel Management, BU# 114009, in the amount of \$344,449.
 - 7. NN Department of Workforce Development, BU# 114010, in the amount of \$10,856.
 - 8. Department of Water Resources, TCOB, BU# 115012, in the amount of 209,607.
 - 9. Navajo Land Department, BU# 115021, in the amount of \$209,334.
 - 10. Navajo School Clothing Program# 117008, in the amount of \$1,952,400.

SECTION FOUR. DIRECTIVE TO THE OFFICE OF MANAGEMENT AND BUDGET

- A. The Navajo Nation Council directs the Office of Management and Budget to immediately recalculate the final monetary totals such that the figures conform to the amendments passed by the Navajo Nation Council.
- B. The Navajo Nation Council directs the Office of Management and Budget to make any other changes to the exhibits such that they conform to the amendments passed by the Navajo Nation Council.

SECTION FIVE. EFFECTIVE DATE

The Navajo Nation Amended Fiscal Year 2026 Comprehensive Budget enacted herein shall be effective pursuant to 2 N.N.C. §§ 164(A)(17) and 221(B).
