

OPERATIONS FOR ONE MONTH OF FISCAL YEAR 2026

BE IT ENACTED:

SECTION ONE. AUTHORITY.

- A. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 700(A).
- B. The Naabik'iyáti' Committee oversees the operations for the Office of Legislative Services. 2 N.N.C. § 700(A)(5).
- C. A standing committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight. 2 N.N.C. §185(A).
- D. A budget reallocation is the transfer or reallocation of budget funds between business units which requires oversight approval. Navajo Nation Budget Instruction Manual Fiscal Year 2026, Section XII(C)(2).

1 E. A reallocation of funds must be approved "by two-thirds (2/3) vote of the full  
2 membership of the committee, board or commission." 2 N.N.C. §185(A).

4 **SECTION TWO. FINDINGS.**

5 A. Due to Navajo Nation President Nygren line-item vetoes of the Legislative District  
6 Assistants Program ("LDAP") in CS-44-25, LDAP is in need of a budget reallocation  
7 from the Office of the Speaker in the amount of \$177,434. See CS-44-25.

8 B. A Budget Revision Request Form reflecting the reallocation from the Office of the  
9 Speaker to LDAP is attached as **Exhibit A**.

11 **SECTION THREE. APPROVING A REALLOCATION OF \$177,434 FROM THE**  
12 **OFFICE OF THE SPEAKER, BUSINESS UNIT 101015 (OFFICE OF THE**  
13 **SPEAKER) TO THE LEGISLATIVE DISTRICT ASSISTANTS PROGRAM,**  
14 **BUSINESS UNIT 101034 TO FUND THE PROGRAM FOR ONE MONTH OF**  
15 **FISCAL YEAR 2026.**

16 The Navajo Nation hereby approves a budget reallocation of \$177,434 from the Office of  
17 the Speaker to the Legislative District Assistants Program in accordance with **Exhibit A**.
