**PURPOSE:** The purpose of the resolution is to approve an Addendum to RDCJY-28-25 which approved a lease between the Navajo Nation and Painted Desert Power, LLC to construct, install, and develop a 750-megawatt (750MW) photovoltaic solar generating and battery storage project in the Coalmine Canyon Chapter of the Navajo Nation Reservation. The Addendum concerns rental payments.

APPROVING AN ADDENDUM TO RDCJY-28-25, THE PAINTED DESERT  
POWER SOLAR SITE LEASE FOR PAINTED DESERT POWER, LLC

BE IT ENACTED:

SECTION ONE. AUTHORITY

Pursuant to 2 N.N.C. Section §501 (B)(2), the Resources and Development Committee of the Navajo Nation Council has the authority to grant final approval for all land withdrawals, non-mineral leases, permits, licenses, rights-of-way, surface easements and bonding requirements on Navajo Nation lands and unrestricted (fee) land. This authority shall include subleases, modifications, assignments, leasehold encumbrances, transfers, renewals, and terminations.

SECTION TWO. FINDINGS

A. Resolution RDCJY-28-25 approved a lease between the Navajo Nation and Painted Desert Power, LLC to construct, install, and develop a 750-megawatt (750MW) photovoltaic solar generating and battery storage project in the Coalmine Canyon Chapter of the Navajo Nation Reservation.

1 B. An Addendum to the Lease has been negotiated between the Lessor, the Navajo Nation  
2 and the Lessee, Painted Desert Power, LLC. The Addendum provides:

3 *“(C) Commencing on the Commercial Commencement Date, rent shall begin to accrue*  
4 *at the rate of five hundred forty-five dollars (\$545.00) per-acre-per-year, with an*  
5 *annual escalator of two percent (2.00%) starting on the first anniversary of the*  
6 *Commercial Commencement Date and continuing each year thereafter until the earlier*  
7 *of the expiration or termination of this Lease Agreement, paid by the Lessee to the*  
8 *Lessor in a single lump sum payment each year commencing on the Commercial*  
9 *Commencement Date and, thereafter, on or before the first day of each anniversary of*  
10 *the Commercial Commencement Date.”*

11 C. The Addendum is attached as **Exhibit 1**.

12 D. Resolution RDCJY-28-25 is attached as **Exhibit 2**.

13 E. The Addendum been reviewed by the Navajo Nation Department of Justice (NNDOJ)  
14 and found to be legally sufficient. The NNDOJ Request for Services Cover Sheet is  
15 attached as **Exhibit 3**.

### 16 17 **SECTION THREE. APPROVAL**

18 A. The Resources and Development Committee of the Navajo Nation Council hereby  
19 approves the Addendum, attached as **Exhibit 1**, to the RDCJY-28-25 lease.

20 B. The Resources and Development Committee of the Navajo Nation Council hereby  
21 authorizes the President of the Navajo Nation to execute any and all documents  
22 necessary to affect the intent and purpose of this resolution.
