AN ACTION

RELATING TO THE BUDGET AND FINANCE AND NAABIK'ÍYÁTI'  
COMMITTEES, AND THE NAVAJO NATION COUNCIL; APPROVING  
A BUDGET REVISION REQUEST FOR THE OFFICE OF LEGISLATIVE  
COUNSEL TO FUND OPERATING EXPENSES; WAIVING THE BUDGET  
INSTRUCTION MANUAL PROHIBITION ON BUDGET REVISIONS FROM  
PERSONNEL ACCOUNTS TO NON-PERSONNEL ACCOUNTS; WAIVING CJY-  
66-23, SECTIONS 3(A) AND 3(B)(1) AND (2)

BE IT ENACTED:

SECTION ONE. AUTHORITY

A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council that is authorized to review and make recommendations on the management of funds. 2 N.N.C. § 300(A) and (B)(2).

B. The Naabik'iyáti' Committee is a standing committee of the Navajo Nation Council that reviews all proposed resolutions requiring final action by the Council. 2 N.N.C. § 164(A)(9).

C. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. § 102(A).

D. Navajo Nation Council Resolution CJY-66-23 Section 3(A) and 3(B)(1) and (2) and the

1 Fiscal Year 2026 Budget Instructions Manual prohibits budget revisions from personnel  
2 accounts to non-personnel accounts.

3 E. Waiver of any provision in CJY-66-23 requires a two-thirds (2/3) vote of the full  
4 membership of the Navajo Nation Council.

5  
6 **SECTION TWO. FINDINGS**

7 A. The Office of Legislative Counsel (“OLC”) requests approval of a budget revision in the  
8 amount of \$285,112.57, as reflected in the attached budget revision request, attached as  
9 **Exhibit A**, to fund essential operating expenses for Fiscal Year 2026.

10 B. Due to line-item vetoes exercised by Navajo Nation President Buu Nygren in the FY  
11 2026 Comprehensive Budget, all non-personnel operating expense line items for the  
12 OLC were eliminated. As a result, the OLC has no appropriated funding for non-  
13 personnel operating expenses necessary to carry out its statutory duties and  
14 responsibilities.

15 C. The elimination of non-personnel operating funds has severely impaired the OLC’s  
16 ability to maintain ample funding necessary to comply with mandatory State of Arizona  
17 attorney licensing requirements, including annual bar dues, continuing legal education,  
18 and related professional obligations, which are required for OLC attorneys to remain in  
19 good standing with the State Bar of Arizona and lawfully perform legal services on behalf  
20 of the Navajo Nation.

21 D. Following the line-item vetoes to the FY 2026 Comprehensive Budget, the OLC  
22 submitted a request for funding from the Unreserved, Undesignated Fund Balance  
23 (“UUFB”) to restore essential operating expenses for FY 2026; however, that request  
24 was also line-item vetoed by Navajo Nation President Buu Nygren, leaving the OLC  
25 without any approved source of non-personnel operating funds.

26 E. In order to ensure the continued operation of the OLC and to allow it to fulfill its  
27 responsibilities as required under Navajo Nation law, approval of the requested budget  
28 revision is necessary and in the best interest of the Navajo Nation.

29 F. To restore essential operating expenses for FY 2026, the OLC requests approval of a  
30 budget revision that would move funds from its personnel account to a non-personnel

1 account.

2 **SECTION THREE. APPROVAL**

3 The Navajo Nation Council hereby approves the Office of Legislative Counsel's Budget  
4 Revision Request as shown in the attached **Exhibit A**.

5  
6 **SECTION FOUR. WAIVERS OF NAVAJO NATION LAW**

7 A. The Navajo Nation waives Sections 6(D) and 12(D)(12)(a) of the BIM that restrict budget  
8 revisions from personnel accounts to non-personnel accounts.

9 B. The Navajo Nation waives Sections 3(A) and 3(B)(1) and (2) of Council Resolution CJY-  
10 66-23.

11  
12 **SECTION FIVE. EFFECTIVE DATE**

13 This Action shall become effective in accordance with 2 N.N.C. §221(C).

14  
15 **SECTION SIX. SAVING CLAUSE**

16 If any portion of this Action is determined invalid by the Navajo Nation Supreme Court, or by a  
17 District Court of the Navajo Nation without appeal to the Navajo Nation Supreme Court, the  
18 remainder of this Action shall be the law of the Navajo Nation.
