This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.



16 BE IT ENACTED:

18 **SECTION ONE. AUTHORITY**

- 19 A. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C.
20 §102(A).
- 21 B. The Director of the Office of Legislative Services is confirmed by the Navajo Nation
22 Council. 2 N.N.C. §953(A).
- 23 C. The Naabik'iyáti' Committee has legislative oversight authority over the Office of
24 Legislative Services. 2 N.N.C. §701(A)(5).
- 25 D. A proposed resolution requiring final action by the Navajo Nation Council shall be
26 assigned to the Naabik'iyáti' Committee. 2 N.N.C. §164(A)(9).

28 **SECTION TWO. FINDINGS**

- 29 A. The Speaker of the Navajo Nation Council shall recommend for appointment a person to
30 serve as the Executive Director of the Office of Legislative Services, with confirmation

1 by the Navajo Nation Council. 2 N.N.C. §953(A).

2 B. The appointed Executive Director of the Office of Legislative Services serves at the
3 pleasure of the Naabik'iyáti' Committee. 2 N.N.C. §953(A).

4 C. The Speaker of the Navajo Nation Council wishes to appoint Rodeny L. Tahe as the
5 Executive Director of the Office of Legislative Services.

6 D. Given Mr. Tahe's experience and background with the Office of the Legislative Services
7 and the Legislative Branch, Mr. Tahe is qualified to serve as the Executive Director of the
8 Office of Legislative Services. Mr. Tahe's letter of interest, resume, and Certificate of
9 Indian Blood are attached as **EXHIBIT A**.

11 **SECTION THREE. CONFIRMING THE APPOINTMENT OF RODENY L. TAHE AS**
12 **EXECUTIVE DIRECTOR OF THE OFFICE OF LEGISLATIVE SERVICES**

13 The Navajo Nation Council hereby confirms the appointment of Rodeny L. Tahe as the
14 Executive Director of the Office of Legislative Services.
