

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is established as a standing committee of the Navajo Nation Council with oversight authority over land and community development, to promulgate rules and regulations for the development of Navajo Nation lands, and to provide final approval for land permits. 2 N.N.C. §§ 500 (A), 501 (B) (1) and 501 (B) (2).
- B. The Resources and Development Committee serves as the Legislative oversight authority for the Division of Economic Development. 2 N.N.C. § 501 (C) (1).
- C. References in the Navajo Nation Code and other official documents to the Economic Development Committee shall mean the Resources and Development Committee.
