BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council, empowered to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds. 2 N.N.C. §§ 300(A) and 301(B) (2). This allows the Budget and Finance Committee to oversee fixed costs.
- B. A standing committee may reallocate funds appropriated by the Navajo Nation Council to a division or program over which the committee has oversight authority. 2 N.N.C. § 185(A).
- C. A budget reallocation is the reallocation of funds between business units which shall require oversight committee approval. Navajo Nation Fiscal Year 2026 Budget Instructions Manual, Section 12 (C)(2).

1 D. A reallocation of funds must be approved "by two-thirds (2/3) vote of the full
2 membership of the committee, board or commission." 2 N.N.C. § 185(A).
