- 27 A. The Navajo Housing Authority has prepared the Fiscal Year 2027 Navajo Nation
28 Housing Plan for the NAHASDA Indian Housing Block Grant which is attached

1 B. The Board of Commissioners of the Housing Authority, by Resolution NHA-
2 5357-2026, attached hereto as **Exhibit B**, requests the support and endorsement
3 of the Resources and Development Committee of the Navajo Nation Council and
4 request authorization to submit Navajo Nation's FY 2027 Indian Housing Plan
5 to the United State Department of Housing and Urban Development on behalf
6 of the Navajo Nation.
