RELATING TO THE LAW AND ORDER COMMITTEE AND BUDGET AND
FINANCE COMMITTEE; APPROVING AND RECOMMENDING THE FISCAL
YEAR 2027 BUDGET FOR THE NAVAJO NATION ETHICS AND RULES OFFICE
AND RELATED MATTERS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Law and Order Committee is a Standing Committee of the Navajo Nation Council with oversight authority over the Navajo Nation Ethics and Rules Office. 2 N.N.C. § 600(A); 2 N.N.C. § 601 (B)(15) and (C)(1).
- B. The Law and Order Committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).
- C. The Budget and Finance Committee is a Standing Committee of the Navajo Nation Council with the power to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds. 2 N.N.C. §300(A) and 2 N.N.C. § 301(B)(2).
- D. The Budget and Finance Committee shall review and make recommendations concerning the budget according to the annual budget instructions to the Navajo Nation

1 Council. 12 N.N.C. § 840(A).

3 **SECTION TWO. FINDINGS**

- 4 A. The Law and Order Committee and the Budget and Finance Committee held budget
5 meetings and heard reports from Program staff and the Office of Management and
6 Budget regarding the proposed Fiscal Year 2027 ("FY2027") Budget for the Navajo
7 Nation Ethics and Rules Office. 12 N.N.C. § 840(A).
- 8 B. The Law and Order Committee, Committee Report shall be attached as **Exhibit G** and
9 the Budget and Finance Committee, Committee Report shall be attached as **Exhibit H**.
- 10 C. Pursuant to the Navajo Nation Appropriations Act, Oversight Committee budget
11 recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).

- 17 A. The Law and Order Committee hereby recommends the FY2027 Budget for the Navajo
18 Nation Ethics and Rules Office, as detailed in the "Fund Type Budget Summary"
19 attached hereto as **Exhibit A**, and in the Law and Order Committee's Report, to be
20 attached as **Exhibit G**.
- 21 B. The Law and Order Committee hereby approves certain revisions, if any, to the
22 proposed FY2027 Budget amount for the Navajo Nation Ethics and Rules Office, as
23 shown in Columns D and E in the "General Fund Comparative Summary" attached
24 hereto as **Exhibit B**, and in the Law and Order Committee's Report to be attached as
25 **Exhibit G**.
- 26 C. The Law and Order Committee recommends the changes, if any, to the General Fund
27 Budget described in **Exhibit C**, and in the Law and Order Committee's Report to be
28 attached as **Exhibit G**.
- 29 D. The Law and Order Committee recommends certain Conditions of Appropriation and
30 Legislative Concerns, if any, as listed in **Exhibit D**, and in the Law and Order

- 1 Committee's Report to be attached as **Exhibit G**.
- 2 E. The Law and Order Committee recommends that certain Unmet Needs, if any, for the
- 3 Navajo Nation Ethics and Rules Office be included in the FY2027 Comprehensive
- 4 Budget, as explained in **Exhibit E**. and in the Law and Order Committee's Report to
- 5 be attached as **Exhibit G**.
- 6 F. The Law and Order Committee has been presented with the External Funds Anticipated
- 7 in FY2027, if any, as listed in **Exhibit F**.
- 8 G. The Law and Order Committee recommends that the Budget and Finance Committee
- 9 approve the Navajo Nation Ethics and Rules Office's FY2027 Budget and all
- 10 Committee recommendations as set forth in **Exhibits A-E and Exhibit G**, the Law and
- 11 Order Committee, Committee Report.
- 12 H. The Law and Order Committee hereby authorizes the Chair and the Vice-Chair to
- 13 negotiate with the Budget and Finance Committee on these recommendations.
