AN ACTION

RELATING TO THE LAW AND ORDER COMMITTEE AND BUDGET AND
FINANCE COMMITTEE; APPROVING AND RECOMMENDING THE FISCAL
YEAR 2027 BUDGET FOR THE NAVAJO NATION JUDICIAL BRANCH AND
RELATED MATTERS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Law and Order Committee is a Standing Committee of the Navajo Nation Council with oversight authority over the Navajo Nation Judicial Branch. 2 N.N.C. § 600(A); 2 N.N.C. § 601 (B)(15) and (C)(1).
- B. The Law and Order Committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).
- C. The Budget and Finance Committee is a Standing Committee of the Navajo Nation Council with the power to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds. 2 N.N.C. §300(A) and 2 N.N.C. § 301(B)(2).
- D. The Budget and Finance Committee shall review and make recommendations concerning the budget according to the annual budget instructions to the Navajo Nation

Council. 12 N.N.C. § 840(A).

SECTION TWO. FINDINGS

- A. The Law and Order Committee and the Budget and Finance Committee held budget meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed Fiscal Year 2027 ("FY2027") Budget for the Navajo Nation Judicial Branch. 12 N.N.C. § 840(A).
- B. The Law and Order Committee, Committee Report shall be attached as **Exhibit G** and the Budget and Finance Committee, Committee Report shall be attached as **Exhibit H**.
- C. Pursuant to the Navajo Nation Appropriations Act, Oversight Committee budget recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).

SECTION THREE. LAW AND ORDER COMMITTEE RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2027 BUDGET FOR THE NAVAJO NATION JUDICIAL BRANCH AND RELATED MATTERS

- A. The Law and Order Committee hereby recommends the FY2027 Budget for the Navajo Nation Judicial Branch, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**, and in the Law and Order Committee's Report, to be attached as **Exhibit G**.
- B. The Law and Order Committee hereby approves certain revisions, if any, to the proposed FY2027 Budget amount for the Navajo Nation Judicial Branch, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**, and in the Law and Order Committee's Report to be attached as **Exhibit G**.
- C. The Law and Order Committee recommends the changes, if any, to the General Fund Budget described in **Exhibit C**, and in the Law and Order Committee's Report to be attached as **Exhibit G**.
- D. The Law and Order Committee recommends certain Conditions of Appropriation and Legislative Concerns, if any, as listed in **Exhibit D**, and in the Law and Order Committee's Report to be attached as **Exhibit G**.

- 1 E. The Law and Order Committee recommends that certain Unmet Needs, if any, for the
2 Navajo Nation Judicial Branch be included in the FY2027 Comprehensive Budget, as
3 explained in **Exhibit E**. and in the Law and Order Committee's Report to be attached
4 as **Exhibit G**.
- 5 F. The Law and Order Committee has been presented with the External Funds Anticipated
6 in FY2027, if any, as listed in **Exhibit F**.
- 7 G. The Law and Order Committee recommends that the Budget and Finance Committee
8 approve the Navajo Nation Judicial Branch's FY2027 Budget and all Committee
9 recommendations as set forth in **Exhibits A-E and Exhibit G**, the Law and Order
10 Committee, Committee Report.
- 11 H. The Law and Order Committee hereby authorizes the Chair and the Vice-Chair to
12 negotiate with the Budget and Finance Committee on these recommendations.

14 **SECTION FOUR. BUDGET AND FINANCE COMMITTEE APPROVING THE**

20 Finance Committee's recommendations to the Navajo Nation Council for including in the
21 FY2027 Comprehensive Budget.

27 Committee and that serve as the Law and Order Committee's recommendations to the
28 Budget and Finance Committee.
- 29 B. The Office of Legislative Services shall attach **Exhibit H**, the Budget and Finance
30 Committee's Committee Report, that reflects all amendment(s) made to this Action
