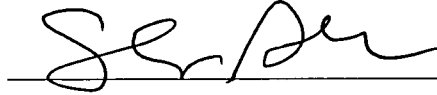

RELATING TO THE BUDGET AND FINANCE COMMITTEE; APPROVING
AND RECOMMENDING THE FISCAL YEAR 2027 BUDGET FOR NAVAJO
NATION FIXED COST PROGRAMS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Fixed Costs for Navajo Nation Programs. 2 N.N.C. §300(A).
- B. Each Oversight Committee, including the Budget and Finance Committee, shall review and make recommendations regarding the programs under its oversight responsibility, regarding the Navajo Nation's Comprehensive Budget for the upcoming Fiscal Year. 12 N.N.C. §840(A).

SECTION TWO. FINDINGS

- A. The Fixed Costs Programs prepared the following document in support of its Fiscal Year ("FY") 2027 Budget:
1. Fund Type Budget Summary, as provided in **Exhibit A**;

2. General Fund Comparative Summary, as provided in **Exhibit B**;
3. Changes to the General Fund Budget, as provided in **Exhibit C**;
4. Recommended Conditions of Appropriation and Legislative Concerns, as provided in **Exhibit D**;
5. Recommended Unmet Needs, as provided in **Exhibit E**.
6. Anticipated External Funds, as provided in **Exhibit F**. This exhibit is provided for information purposes only and as such is not subject to amendment since these are not Navajo Nation General Funds.

B. The Budget and Finance Committee Report, once prepared, will be attached as **Exhibit G**.

SECTION THREE. APPROVING AND RECOMMENDING THE FISCAL YEAR 2027 BUDGET FOR FIXED COSTS FOR NAVAJO NATION FIXED COST PROGRAMS

- A. The Budget and Finance Committee approves the Fixed Costs for 25 Navajo Nation Program's Budget **Exhibits A-E**, as attached to this Resolution.
- B. The Budget and Finance Committee recommends the Navajo Nation Council include the amounts provided in **Exhibits A-E** into the Navajo Nation's Comprehensive Budget for FY 2027.
