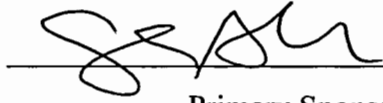

RELATING TO THE BUDGET AND FINANCE COMMITTEE;
RECOMMENDING THE FISCAL YEAR 2027 BUDGET FOR THE
NAVAJO NATION OFFICE OF MANAGEMENT AND BUDGET AND
RELATED MATTERS

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Office of Management and Budget. 2 N.N.C. §§ 300(A), (C), 301(B)(2) and (13).
- B. The Budget and Finance Committee shall make recommendations concerning the budget to the Navajo Nation Council. 12 N.N.C. § 840(A).

SECTION TWO. FINDINGS

- A. The Budget and Finance Committee held budget meetings and heard reports from office staff regarding the proposed Fiscal Year 2027 ("FY 2027") Budget for the Navajo Nation Office of Management and Budget. 12 N.N.C. § 840(A).
- B. The Navajo Nation Office of Management and Budget prepared the following documents in support of its FY 2027 Budget:

1. Fund Type Budget Summary, as provided in **Exhibit A**;
2. General Fund Comparative Summary, as provided in **Exhibit B**;
3. Recommended Changes to the General Fund Budget, as provided in **Exhibit C**;
4. Recommended Conditions of Appropriations and Legislative Concerns, as provided in **Exhibit D**;
5. Recommended Unmet Needs, as provided in **Exhibit E**; and
6. Anticipated External Funds, as provided in **Exhibit F**. This exhibit is provided for information purposes only and as such is not subject to amendment since they are not Navajo Nation General Funds.

C. The Budget and Finance Committee Report, once prepared, will be attached as **Exhibit G**.

SECTION THREE. RECOMMENDING THE FISCAL YEAR 2027 BUDGET FOR THE NAVAJO NATION OFFICE OF MANAGEMENT AND BUDGET

The Budget and Finance Committee has completed its review and recommendation of the Fiscal Year 2027 Budget for the Navajo Nation Office of Management and Budget. Pursuant to 12 N.N.C. § 840(A), this recommendation shall be transmitted to the Navajo Nation Council for consideration in the development of the Navajo Nation's Fiscal Year 2027 Comprehensive Budget as set forth in **Exhibits A-E**.

SECTION FOUR. DIRECTIVE

The Budget and Finance Committee directs the Office of Legislative Services to attach the Budget and Finance Committee Report as **Exhibit G**.

SECTION FIVE. EFFECTIVE DATE

This Action shall become effective in accordance with 2 N.N.C. § 189(A) and (B).
