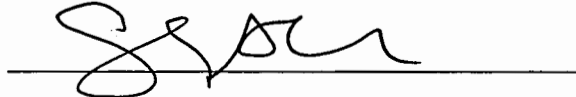

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with oversight authority over the Division of General Services: Insurance Services, Risk Management, Employee Benefits, and Workers Compensation. 2 N.N.C. §§ 300(A), (C), 301(B)(2) and (13).
- B. The Budget and Finance Committee is also authorized to make recommendations to the Council on the budgeting and management of Navajo Nation funds. 2 N.N.C. § 300(A), § 301(B)(2). The Budget and Finance Committee is specifically authorized to make recommendations to the Council regarding the Navajo Nation's annual Comprehensive Budget for each Fiscal Year. 12 N.N.C. § 840(A).

SECTION TWO. FINDINGS

1 A. The Budget and Finance Committee held budget hearings to receive testimony from
2 division, department, and program staff regarding the proposed Fiscal Year 2027
3 ("FY 2027") Budget for the Navajo Nation Division of General Services: Insurance
4 Services, Risk Management, Employee Benefits, and Workers Compensation. 12
5 N.N.C. § 840(A).

6 B. The Navajo Nation Division of General Services: Insurance Services, Risk
7 Management, Employee Benefits, and Workers Compensation prepared the following
8 documents in support of its FY 2027 Budget:

- 9 1. Fund Type Budget Summary, as provided in **Exhibit A**;
- 10 2. General Fund Comparative Summary, as provided in **Exhibit B**;
- 11 3. Recommended Changes to the General Fund Budget, as provided in **Exhibit C**;
- 12 4. Recommended Conditions of Appropriations and Legislative Concerns, as
13 provided in **Exhibit D**;
- 14 5. Recommended Unmet Needs, as provided in **Exhibit E**; and
- 15 6. Anticipated External Funds, as provided in **Exhibit F**. This exhibit is provided
16 for information purposes only and as such is not subject to amendment since
17 they are not Navajo Nation General Funds.

21 **SECTION THREE. RECOMMENDING THE FISCAL YEAR 2027 BUDGET FOR**
