**RELATING TO THE RESOURCES AND DEVELOPMENT COMMITTEE AND
BUDGET AND FINANCE COMMITTEE; APPROVING AND RECOMMENDING
THE FISCAL YEAR 2027 BUDGET FOR THE NAVAJO NATION
ENVIRONMENTAL PROTECTION AGENCY AND RELATED MATTERS**

BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council with oversight authority over the Navajo Nation Environmental Protection Agency. 2 N.N.C. § 500(A); 2 N.N.C. § 501 (C)(1).
- B. The Resources and Development Committee shall review and make recommendations to the Budget and Finance Committee concerning the budget in accordance with the annual budget instructions. 12 N.N.C. § 840 (A).
- C. The Budget and Finance Committee is a standing committee of the Navajo Nation Council with the power to review and recommend to the Navajo Nation Council the budgeting, appropriation, investment and management of all funds. 2 N.N.C. §300(A) and 2 N.N.C. § 301(B)(2).
- D. The Budget and Finance Committee shall review and make recommendations concerning the budget according to the annual budget instructions to the Navajo Nation

Council. 12 N.N.C. § 840(A).

SECTION TWO. FINDINGS

- A. The Resources and Development Committee and the Budget and Finance Committee held budget meetings and heard reports from Program staff and the Office of Management and Budget regarding the proposed Fiscal Year 2027 ("FY2027") Budget for the Environmental Protection Agency. 12 N.N.C. § 840(A).
- B. The Resources and Development Committee's, Committee Report shall be attached as **Exhibit G** and the Budget and Finance Committee's, Committee Report shall be attached as **Exhibit H**.
- C. Pursuant to the Navajo Nation Appropriations Act, Oversight Committee budget recommendations shall not exceed the base planning amounts. 12 N.N.C. § 840(A).

SECTION THREE. RESOURCES AND DEVELOPMENT COMMITTEE RECOMMENDING TO THE BUDGET AND FINANCE COMMITTEE THE FISCAL YEAR 2027 BUDGET FOR THE NAVAJO NATION ENVIRONMENTAL PROTECTION AGENCY AND RELATED MATTERS

- A. The Resources and Development Committee hereby recommends the FY2027 Budget for the Environmental Protection Agency, as detailed in the "Fund Type Budget Summary" attached hereto as **Exhibit A**, and in the Resources and Development Committee's Report, to be attached as **Exhibit G**.
- B. The Resources and Development Committee hereby approves certain revisions, if any, to the proposed FY2027 Budget amount for the Environmental Protection Agency, as shown in Columns D and E in the "General Fund Comparative Summary" attached hereto as **Exhibit B**, and in the Resources and Development Committee's Report to be attached as **Exhibit G**.
- C. The Resources and Development Committee recommends the changes, if any, to the General Fund Budget described in **Exhibit C**, and in the Resources and Development Committee's Report to be attached as **Exhibit G**.
- D. The Resources and Development Committee recommends certain Conditions of

1 Appropriation and Legislative Concerns, if any, as listed in **Exhibit D**, and in the
2 Resources and Development Committee's Report to be attached as **Exhibit G**.

3 E. The Resources and Development Committee recommends that certain Unmet Needs,
4 if any, for the Environmental Protection Agency be included in the FY2027
5 Comprehensive Budget, as explained in **Exhibit E**. and in the Resources and
6 Development Committee's Report to be attached as **Exhibit G**.

7 F. The Resources and Development Committee has been presented with the External
8 Funds Anticipated in FY2027, if any, as listed in **Exhibit F**.

9 G. The Resources and Development Committee recommends that the Budget and Finance
10 Committee approve the Environmental Protection Agency's FY2027 Budget and all
11 Committee recommendations as set forth in **Exhibits A-E and Exhibit G**, the
12 Resources and Development Committee, Committee Report.

13 H. The Resources and Development Committee hereby authorizes the Chair and the Vice-
14 Chair to negotiate with the Budget and Finance Committee on these recommendations.

16 **SECTION FOUR. BUDGET AND FINANCE COMMITTEE APPROVING THE**
17 **FISCAL YEAR 2027 BUDGET FOR THE NAVAJO NATION ENVIRONMENTAL**
18 **PROTECTION AGENCY AND RELATED MATTERS**

19 The Budget and Finance Committee approves the Environmental Protection Agency's
20 FY2027 Budget and all Committee recommendations as set forth in **Exhibits A-E** and in
21 the Budget and Finance Committee's, Committee Report, **Exhibit H**, to serve as the
22 Budget and Finance Committee's recommendations to the Navajo Nation Council for
23 inclusion in the FY2027 Comprehensive Budget.

25 **SECTION FIVE. DIRECTIVES**

26 A. The Office of Legislative Services shall attach **Exhibit G**, the Resources and
27 Development Committee's Committee Report, that reflects all amendment(s) made to
28 this Action (Exhibits and Budget Binder documents) that are approved by the
29 Resources and Development Committee and that serve as the Resources and
30 Development Committee's recommendations to the Budget and Finance Committee.

1 B. The Office of Legislative Services shall attach **Exhibit H**, the Budget and Finance
2 Committee's Committee Report, that reflects all amendment(s) made to this Action
3 (Exhibits and Budget Binder documents) as approved by the Budget and Finance
4 Committee.
